I hold a tenure-track position as Assistant Professor of Intellectual History and Economics in the *School of Civic Leadership* at the University of Texas at Austin. The position comprises the usual range of teaching, research, and service responsibilities.

I am committed to using my role to expand provision in economic history and the history of economic thought at UT.

I was appointed as a senior fellow at the *Civitas Institute*, a think tank and community of scholars focused on themes such as economic dynamism; politics; constitutionalism, and the pursuit of happiness. My role centers on contributions to their economic dynamism stream. I write pieces on issues of current economic interest for a generalist audience and partake in Civitas public events. The institute offers a public-facing platform for my academic work and/or topics that are adjacent to my present academic projects, but are of interest in relation to current policy discourse.

### James Buchanan Fellow (non-resident) - Mercatus Center

Jan 2024 - Dec '24

I was a James Buchanan Fellow in political economy at the *Mercatus Center* research institute, which was ranked as the world's twelfth best university-affiliated think tank by UPenn's Global Think Tank Report. My academic engagement during the fellowship centered on interests in political economy and the history of economic thought, in particular the Virginia and Bloomington schools of political economy. Additionally, I advanced my research on the idiosyncratic New-Keynesian paradigm of the late Nobel Laureate, Professor James Meade. We also deliberated on how the history of economic thought as a discipline can thrive in both economics and history departments alike.

A short piece written for a popular audience, published in the *Civitas Outlook* journal, on the significance of Professor Joel Mokyr winning the 2025 Nobel Prize in Economics. In particular, I focus on its implications for the place of history in economic analysis, both past and present.

A 2500 word piece written for the *Economics Observatory*, an ESRC-funded partner of the National Institute of Economic and Social Research, which aims to bridge the gap between academic expertise, economic policy, and the wider public. ## TEACHING AND OTHER POSITIONS

### Course Convenor - CIV 301F

*2026/27 Academic Year*

I will be leading a course titled *American Political Economy*, which I helped to develop and acquire institutional approval for at UT Austin. It surveys the ideas and policies that have structured the American economic system, and unpacks contentious debates that shaped the course of a nation from the colonial period (c.1600) to the present day.

### Course Convenor - CIV 303K

*2025/26 Academic Year*

I teach a course titled *Democracy and Capitalism*, which explores the historical development of these two concepts as well as the potential complementarities and tensions between them. It includes the study of classic texts in the history of economic thought, in addition to more recent publications in political economy. My range of tasks includes syllabus design and updating; lecturing and leading class groups; conducting office hours, and the grading of assessed work.

### Seminar Teacher - EC204

*Summer Vacations: 2022, 2023 & 2024*

I was a seminar teacher for a financial and monetary history module (*'Financial Markets and the Global Economy: the History of Bubbles, Crashes and Inflations'*), one of the flagship courses at the LSE Summer School. I was pleased to attain the Summer School's benchmark for excellence in my student evaluations every year of teaching the course. The module followed an intensive format with multiple 90 minute

seminars being taught every day. My role included the usual range of duties including: the planning and teaching of daily seminars; marking both formative and summative assignments; dealing with out-of-class queries and being the frontline point of contact for students; invigilation duties during controlled assessment; grading the final examination scripts, and assisting the professor in updating the course reading list in light of student feedback. I have also acted as lead teaching assistant, helping to manage other members of the teaching team on behalf of the course convener.

### **Seminar Teacher - EH101**

*2019/20 Academic Year*

I was a seminar teacher for this wide-ranging undergraduate module ('The Internationalisation of Economic Growth') covering approximately two hundred years of economic history, from the Industrial Revolution right up to the de-industrialisation of the late 20th and early 21st century. The range of duties involved were very similar to those outlined above for my EC204 teaching.

### **Subwarden - LSE Accommodation**

*Sept 2019 - June 2022*

My position as a subwarden saw me working as part of a small team with pastoral and disciplinary responsibilities within LSE accommodation, comprising a mix of 450 undergraduate and postgraduate students. The job entailed being on call during certain evenings and nights to deal with emergencies, as well as scheduled responsibilities that included providing support to at-risk or vulnerable residents; writing regular reports for the LSE's student support services to keep them informed on developments therein; and helping to provide disciplinary oversight within the accommodation. My training included becoming a mental health first aider, accredited by Mental Health First Aid (MHFA) England.
